 - Robert Knapp discussed the idea of getting a notification to prompt him to refresh prior to his dig ticket expiring, also discussed the issues of dig tickets not getting completed "on time" and several issues of "incorrect" locates from third party locating companies. Another concern is when locating companies status a ticket as "not complete in progress" and the abuse of that status and the lack of locating companies communicating with contractors.
